## A note about salary and benefit figures

The stated compensation figure represents a total package value that includes a cash stipend, pension, and the diocese's contribution towards medical insurance, depending on the employee's selected coverage level (Individual, Individual +1, or Family).

# Sources of Funds for Ministry: The Foundation of Our Work

Our shared ministry is made possible through the faithful stewardship of our congregations and the prudent management of our shared resources. This income allows us to fund the vital work across our diocese.



Assessments \$3,750,000

The primary source of funding for our diocesan budget.
Assessments are a percentage of each congregation's operating revenue, representing a shared commitment to our common mission and ministry.



#### **Endowment & Fees**

\$1,015,000

Includes draws at 4% or \$550,000 from our diocesan endowment funds available for operations which total approximately \$13,750,000. The draws are calculated using a three year rolling average. This provides a stable, long-term source of income for our ministries. Fees for services, such as payroll and benefits and planned giving administration totaling \$465,000, provide additional benefits to our congregations.



## **Expanding Horizons**

\$18,000

Funds from the Expanding Horizons campaign designated to support specific ministry areas. This funds our regional deans.



## **Bishop's Discretionary**

\$125,000

Income from the Christy Fund, designated for the Bishop's discretionary use in responding to immediate needs and unique ministry opportunities across the diocese.



#### **Interest Income**

\$40,000

Interest earned on our financial accounts.

# FUNDS USED FOR MINISTRY: LIVING OUR MISSION I. Episcopate

The Episcopate provides spiritual leadership, pastoral care, and administrative oversight for the entire diocese. This ministry ensures that our clergy and congregations are supported, our worship is ordered, and our collective vision is guided by the Gospel.

Salary and Benefits	\$ 476,123
Bishop	\$ 342,500
Executive Assistant	\$ 122,125
Archdeacon	\$ 11,498

Compensation for the Bishop, Archdeacon, and the Executive Assistant to the Bishop, who collectively provide leadership and administrative support for the diocese.

## **Episcopal Residence R&M**

\$35,000

Funds the repair and maintenance of the Episcopal residence, ensuring it remains a suitable home and place of hospitality.



## **Archdeacon Ministry**

<u>\$26,000</u>

Supports the Archdeacons' work as a key extension of the Bishop's pastoral and administrative arm, overseeing deacon deployment and supporting clergy wellness. These funds also support the work of the Deacon's Council.

## **School for Deacons**

\$36,000

Equips and forms theologically grounded deacons for ministry in the world, focusing on outreach, social justice, and connecting the church to the community.

## Deaneries & Regional Deans \$33,000

Fosters localized support, collegiality, and shared ministry among clergy and lay leaders in their regional areas. Deans serve as a vital link between local churches and the broader diocese.

## Clergy Conference \$10,000

Provides for the annual clergy conference, a vital time for the ongoing formation, spiritual health, and collegial development of our diocesan clergy.

## Bishop's Travel & Entertainment

\$37.000

Covers the costs associated with the Bishop's travel throughout the diocese for visitations and meetings, as well as hospitality for diocesan events hosted by the Bishop.

## Strategic Vision Implementation

\$25,000

This covers expenses related to the implementation of Phase One of the Strategic Vision Plan.

## <u>Travel - House of Bishops</u>

\$7,000

Funds the Bishop's participation in House of Bishops meetings, ensuring our diocese is represented in the wider church.

## **Accrual for Lambeth**

\$3,000

Sets aside funds for the Bishop's attendance at the Lambeth Conference, a gathering of bishops from across the Anglican Communion held once a decade.

## **Accrual for Bishop Election**

\$15,000

Sets aside funds for the complex and significant process of electing a new bishop when the time comes.

#### **Accrual for General Convention**

\$28,000

Supports the travel and expenses of our lay and clergy deputies to the General Convention, the primary governing and legislative body of The Episcopal Church.

## **Diocesan Events & Hospitality**

\$30,000

Funds events like the Chrism Mass and other diocesanwide gatherings that foster a sense of community through shared worship, learning, and fellowship.

## II. Public Witness & Support of the Wider Church

This area of ministry is our commitment to living out the Gospel command to seek and serve Christ in all persons and to strive for justice and peace. It coordinates our diocesan efforts in racial reconciliation, social justice, and environmental stewardship, and it connects us to the mission and ministry of the broader Episcopal Church.

#### **Salary and Benefits**

Canon for Racial, Social, and Environmental Justice

\$168,148

Compensation for the Canon for Racial, Social, and Environmental Justice (RSEJ), who leads and coordinates the diocese's efforts in these critical areas.

## **Program Support**

<u>\$20,000</u>

Funds to coordinate our diocesan efforts in racial reconciliation, social justice, and environmental stewardship.





#### Travel

\$4,050

Covers travel expenses to visit congregations, lead trainings, and to be present throughout the diocese and the Episcopal Church.

## **Multicultural Ministries**

\$24,000

Dedicated funding for our diverse commissions, including the Afro-Anglican, Asian, Latino, and Indigenous ministries.

## **Peace and Justice Work**

\$24,000

Dedicated funding for diocesan task forces engaging in justice work, disaster ministries,

and the Sojourn Chaplaincy at San Francisco General Hospital.

## **Camp Ministries**

\$51,000

Provides scholarships to ensure that children and youth from all congregations have the opportunity to experience the transformative community of our diocesan camp programs. Our support goes to The Bishop's Ranch and St. Dorothy's Rest.

## **The Episcopal Church**

\$583,333

Our share of support for the mission and ministry of The Episcopal Church, which provides resources, programs, and infrastructure that benefit every congregation, diocese and the broader Anglican Communion.



## Province VIII \$12,000

Our contribution to Province VIII, our regional body of dioceses in the western United States, which facilitates collaboration and shared ministry. Province VIII is one of the most culturally diverse provinces of the Episcopal Church, and includes the dioceses of Navajoland, Taiwan, Micronesia, and Guam as well as dioceses in the Western United States.

## III. Congregational Ministry & LifeLong Formation

This is the heart of our direct support to the 70+ congregations and communities of faith in our diocese. We equip and network congregations with tools for spiritual growth, walk alongside them in times of transition, and provide resources for faith formation that lasts a lifetime, from childhood through adulthood.

## **Mission Support**

\$455,000

\$ 170,000

Direct financial support for the ministry and leadership in our mission congregations, ensuring the ongoing presence of the church in strategic and developing communities. This support takes the form of budget assistance and funds set aside for legal expenses, building repairs and maintenance. This is a \$50,000 increase from the 2025 budget. *The subsidies below are preliminary and subject to change.*

## III. Congregational Ministry & LifeLong Formation

## **Program Support**

<u>\$76,700</u>

Funds a wide array of programs that directly serve congregations, including: Leadership Formation (vestry & warden training), Congregations in Transition (search committee support), Fresh Start (support for clergy in new calls), Interim Ministry training, and support for clergy of mission congregations.

## **Campus Ministry**

\$83,000

Supports our vital ministries with students, faculty, and staff at Stanford, UC Berkeley, and SF State, providing a justice-minded, progressive faith community for young adults.

<u>Travel</u> \$6,000

Covers travel expenses for the Congregational Ministry and Formation staff to visit congregations, lead trainings, and be present throughout the diocese.

## **Total Congregational Ministry**

\$1,395,777



#### IV. Communications & Church Governance

This ministry provides the essential infrastructure for our life together, ensuring we can connect, communicate, and govern ourselves effectively, transparently, and inclusively. It is the behind-the-scenes work that holds us together, from managing our digital presence to running our annual Diocesan Convention.

Salaries and Benefits\$ 293,337Canon for Communications\$ 175,517Comm. Associate\$ 117,820

Compensation for our two-person communications team, who manage the diocesan website, newsletters, social media, event logistics, and pastoral communications.



## Communications Program Expenses

<u>\$20,000</u>

Covers the cost of our digital platforms, including website hosting and security, email marketing services, and other tools that power our digital ministry.



#### **Diocesan Convention**

\$35,000

Funds our largest annual gathering. This covers A/V production, equipment rental, real-time voting systems, signage, accessibility services, and facility coordination to ensure a smooth, participatory, and inclusive event for all delegates.



## Interpretation & Translation

\$25,000

Ensures that our diocesan gatherings and communications are accessible to all, particularly by providing Spanish-language interpretation and translation.

#### IV. Communications & Church Governance

#### **Commission on Ministry (COM)**

\$15,000

Supports the work of the COM, the diocesan body responsible for supporting all the baptized in the discernment, formation and exercise of their ministries.

#### **Executive Council**

\$7,500

Funds the meetings and work of the Executive Council, which acts as the steward of our diocesan resources and implements the decisions of Convention.

## **Standing Committee**

\$3,000

Funds the meetings of the Standing Committee, which serves as an advisory council to the bishop and has canonical responsibilities related to congregational property and clergy ordination.

## **Ordination Process Support**

\$4.000

Designated to support candidates and postulants throughout the ordination process, including psychological evaluations and background checks.


## **Communications Travel**

\$6,000

Covers travel for Communications staff related to convention planning, travel around the diocese, and continued professional development.

## V. Finance & Administration

This is the operational backbone of the diocese, ensuring the faithful and professional stewardship of our financial resources. This department handles accounting, human resources, property management, and IT, providing essential, centralized services that allow congregations and ministries to focus on their mission.

Compensation for the CFO, accountant, and staff who manage payroll, benefits, accounts payable, estates, facilities, archives, and auditing.



#### **Financial Statement Audit**

<u>\$48,500</u>

The cost of our annual independent financial audit, a key practice of transparency and accountability.



## **Bank & Payroll Fees**

\$199,125

The direct cost of banking services and payroll processing fees. The diocese underwrites a significant portion of this cost for congregations using our payroll service.



## **Continuing Ed & Licenses**

\$6,000

Ensures our finance staff remain current with professional standards and certifications.

#### V. Finance & Administration



Travel \$9,000

Covers travel for finance staff for meetings and training.



**Medical Premiums (Retired)** 

**\$15,840** 

Provides for the Medicare Supplemental insurance premiums for retired clergy widows. This benefit program was sunsetted and is no longer offered to new retirees.



**Diocesan House Maintenance** 

<u>\$45,000</u>

The operational cost of maintaining our diocesan headquarters at 1055 Taylor Street, including repairs and upkeep.



**Chancellor & Legal** 

\$125,000

Retainer for the Chancellor (our diocesan legal officer) and other legal fees required for diocesan and congregational matters.



IT Support & Software

\$140,000

Covers the cost of our IT infrastructure, including hardware, software licenses, and support services that are essential for modern ministry operations.



**Property & Liability Insurance** 

\$130,000

Provides for the master insurance policies that cover diocesan properties and liabilities.



**Outside Services** 

<u>\$5,000</u>

Funds for specialized contract services as needed.



Real Estate Expense

\$25,000

Expenses associated with managing diocesan properties, including vacant land in Brentwood.




